



## ATTACHMENT J SWORN STATEMENT OF ANTICORRUPTION CODE

As of the date I am signing this sworn statement, the undersigned, the Proposer, its president, vice president, director, chief executive officer, members of the board of officers or directors, and persons performing equivalent functions for the Proposer have not been convicted or found guilty in state or federal court, or in any other jurisdiction of the United States, of any of the following offenses: (a) aggravated misappropriation; (b) extortion; (c) sabotage of essential public utilities; (d) forgery of documents; (e) fraud; (f) computer fraud; (g) construction fraud; (h) fraudulent use, possession, or transfer of electronically striped cards; (i) unlawful enrichment; (j) unlawful enrichment of a public official; (k) unjust enrichment; (l) unlawful exploitation of public works or utilities; (m) improper interference in government operations; (n) dealing inconsistent with the exercise of a public office; (o) alteration or mutilation of property; (p) false certifications; (q) bribery in all its forms; (r) undue influence; (s) embezzlement of public funds; or (t) money laundering.
3. As of the date I am signing this sworn statement, and during the past twenty (20) years, neither the undersigned, nor the Proposer, nor any of its following officers: president, vice president, director, executive director, or member of the board of directors, officers or directors, or persons performing equivalent functions for the proposer or bidder, has been convicted or pleaded guilty in state or federal court, or in any other jurisdiction of the United States, for any of the following offenses: (a) aggravated damages; (b) title retention; (c) alteration or mutilation of property; (d) filing false documents or data; (e) unlawful possession and use of information, receipts, and proof of tax payments; (f) unlawful purchase and sale of property in payment of taxes; (g) filing of false documents; (h) unlawful possession of tax receipts; (i) falsification of entries in registries; (j) forgery of seals; (k) negligent misrepresentation; (l) falsification of licenses, certificates and other documents; (m) falsification in the exercise of professions or trades; (n) possession and transfer of falsified documents; (o) possession of instruments for falsification; or (p) preparation of false documents.
4. As of the date I am signing this sworn statement, and during the past eight (8) years, neither the undersigned, nor the Proposer, nor any of the following officers: president, vice president, director, executive director, or member of the board of directors or persons performing equivalent functions for the Proposer, has been convicted or pleaded guilty in state or federal court, or in any other jurisdiction of the United States, for any of the following offenses: (a) breach of duty; (b) unlawful sale of property; (c) breach of obligations; (d) negligence in the performance of duty; (e) usurpation of public office; or (f) obstruction of the inspection of books and records.
5. As of the date I sign this sworn statement, and during the last ten (10) years, neither the undersigned, nor the Proposer, nor any of its following officers: president, vice president, director, executive director or member of the board of officers or directors or persons performing equivalent functions for the Proposer, has been convicted or pleaded guilty in state or federal court, or in any other jurisdiction of the United States, for felonies against the exercise of public office or against public funds codified in the Penal Code of Puerto Rico; Act No. 1-2012, as amended, known as the "Government Ethics Office Organic Act "; or any other as provided in Act No. 2-2018, as amended, known as the "Anticorruption Code for the New Puerto Rico".
6. I understand and accept the obligation to report any changes to the content of this statement during the contracting process or the term of the contract, whether due to an allegation of guilt or conviction for any of the aforementioned crimes, or any other conduct prohibited in the "Code of Ethics for Contractors, Suppliers, and Applicants" of the "Economic Incentives

of the Executive Agencies of the Government of Puerto Rico," Anticorruption Code for the New Puerto Rico, Title III, Act No. 2-2018.

7. I understand and accept that a conviction following this statement for any of the offenses listed in any of the preceding paragraphs shall result, in addition to any other penalty, in the automatic termination of any contract between the undersigned, the Proposer, and any government entity, public corporation, or agency.

The undersigned and the Proposer, as the case may be, agree to comply with the provisions of the "Code of Ethics for Contractors, Suppliers and Applicants for Economic Incentives of the Executive Agencies of the Government of Puerto Rico", Anticorruption Code for the New Puerto Rico, Title III, Act No. 2-2018.
9. I sign this sworn statement in accordance with the provisions of Act No. 2-2018, and the requirements of this Request for Sealed Proposals.
10. I give this sworn statement so that any government entity, public corporation, or agency may be aware of the information provided herein for any administrative and/or legal purpose.
